Igniting Systemic Change So Artists Continue to Thrive

Over the past months, Creatives Rebuild New York has been making progress towards a renewed social contract that centers trust and dignity for artists as workers, including releasing our policy playbook, publishing the initial findings from our Guaranteed Income program, founding the New York State Cash Alliance, and more. Our Executive Director Sarah Calderón reflects on what we've accomplished and what's to come in the fight for lasting systemic change.

"Artists and workers are already at a disadvantage in our economy, and in the face of a new federal administration and elected officials, there is heightened urgency to act now. States like New York already have momentum to implement protections for vulnerable communities, fund new employment programs, and pass policies that expand and strengthen worker rights. Artists need deeper change in their working and living conditions for creativity to thrive. CRNY has championed a renewed social contract that centers trust and dignity for artists as workers. We've connected members of our community with resources to continue working and serving communities, but we need improved policy to improve conditions for all."

# New Report Details Impacts of the CRNY Artist Employment Program



report detailing the impacts of CRNY's groundbreaking Artist Employment Program (AEP). The report, Empowering Artists through Employment, along with an accompanying web feature, captures the results of this two-year-long employment program. Funded by CRNY, the research focuses specifically on the two employment models comprising the AEP: artists were either employed directly by their partner organization or employed by Tribeworks, a worker cooperative that provided salaries and benefits for artists. Tribeworks made it possible for smaller organizations with less infrastructure to support employment and benefits for AEP artists. The report analyzes the implementation, outcomes, and impact of the AEP through these employment models.

"Extending benefits and protections to AEP artist participants had positive effects on their emotional and financial well-being, and illustrates the value of extending wage and hour, anti discrimination, and health and safety laws to independent contractors," said Mark Treskon, a Principal Research Associate at the Urban Institute and a co-lead of the study. "This research highlights the importance of treating artists as workers within the larger context of workforce policy. It also underscores the problems inherent in systems that link benefits and protections to jobs rather than people."

## **New York State Cash Alliance**

In partnership with <u>Win</u>, <u>Children's Defense Fund-New York</u>, and other advocates, Creatives Rebuild New York formed the <u>New York State Cash Alliance</u>, a diverse coalition of advocates, community organizers, cash beneficiaries, direct-service providers, policymakers, researchers, and artists who are organizing for a guaranteed income and aligned policies that expand access to unrestricted cash in New York State. The Cash Alliance has been formed in response to economic problems facing New Yorkers: the rising cost of housing, inflation, wage stagnation, and the increasing demand for working multiple jobs.</u>
Guaranteed income is an evidence-based solution for rebalancing the economy for everyone, but especially those who need it most urgently.
